### 3/10/22 Comments and Questions from 3/10 meeting

- 2. I have been ignored for nearly a year asking what the Board and District is doing to address the low morale among staff. I will reiterate, we, as a community and a district have been aware of this for nearly a year. Pretending like it's not a problem doesn't make it go away, it deepens the divide. As a parent, it breaks my heart that our teachers sit through these long meetings to bring low workplace morale to your attention (time and time again) and ask for something as simple as a coffee, to talk. I would like to volunteer to work with any Board member and the BHEA to figure out an action plan to: organize meetings, town halls or coffees so that we can become a "WE" and no longer an "us" versus "them."
- 3. Meetings have been reduced, this is a fact and the data going back to 2014 backs that up. We went from 19 meetings a year and, over time, meetings have since been reduced to 12/13 meetings per year. Does the Board have a goal for meeting length time? I do not believe it is fair to administrators, Board members or residents to sit through a 4 - 5+ hour meeting on a weeknight. I would like to ask the Board to consider adding more meetings, especially on nights when there is a presentation or training happening, as it takes a great deal of time get to the agenda, deliberation and citizens hearings.
