Good morning,

On the 1/19 agenda, you will see the appointment of a Custodian of Record. The personnel committee met regarding this on 12/15/2022. Here are the minutes from that meeting:

- Due to the overwhelming amount of Opras (some taking up to 95 hours of work from Ms. Kot), she is unable to do the main functions of her job. It is the same 6-8 people who consistently OPRA tedious amounts of data that must be redacted. Our options are to stipend this position out, or send it all to the attorney; thus costing hundreds of thousands of dollars. While we would love for these people to just stop with the insanity, we have no control over that.
- Mr. D'Aquila stated that the town had to do the same thing due to the amount of OPRAS. Mrs. Penna asked if we could remove the stipend if the OPRAS became reasonable, which we agreed. Mr. Cianciulli voiced concerns about the public.
- o Dr. Varley and Ms. Kot stated that the people who will voice their concerns are the same ones who are inundating us with OPRAS.

The main function of Ms. Kot's job is ensuring our bills are paid, health benefits are paid, employees are paid, we have enough money to run the district and that students and staff get the resources they need to be successful. With her spending days upon days answering these tedious OPRA requests, she is unable to get her job done. She works long hours. With budget season in full swing, there is absolutely no way she can do all of this. No one takes the BA position to be the OPRA person.

We had two people interview for the position. One was clearly more organized and diligent than the other. That individual will go on the 1/19 agenda. As the minutes state, we will abolish this stipended position as soon as these individuals stop with their nonsense.

Just as an FYI, they have OPRA'd all of my emails and when they didn't find anything, they have moved on to Board members. Please make sure that there is nothing in your email that you do not want public. As our attorney has stated, pick up the phone.

Julie is leaving for a much needed vacation next week. If you have questions about this position, please contact her today. I'll answer questions next week while she is away.
