Millburn has the budget I referenced earlier, attached below:

New Providence does a similar process to Millburn; holding a public meeting to review and discuss the tentative budget PRIOR to the initial vote (which occurs 2+ weeks after it's public reveal - giving the Finance committee time to make changes after public and Board input), in addition to a detailed schedule of budget planning which is a highly transparent process.

But, it's not about comparing Budgets, it's about the lack of transparency surrounding the Budget and the process by the Board and the Administration.

You and your Board members should be doing at least as much or better than our neighboring towns rather than seeming elusive and combative when questioned about yet another deeply flawed process that was promised to "be better."
