Revenue Assumptions

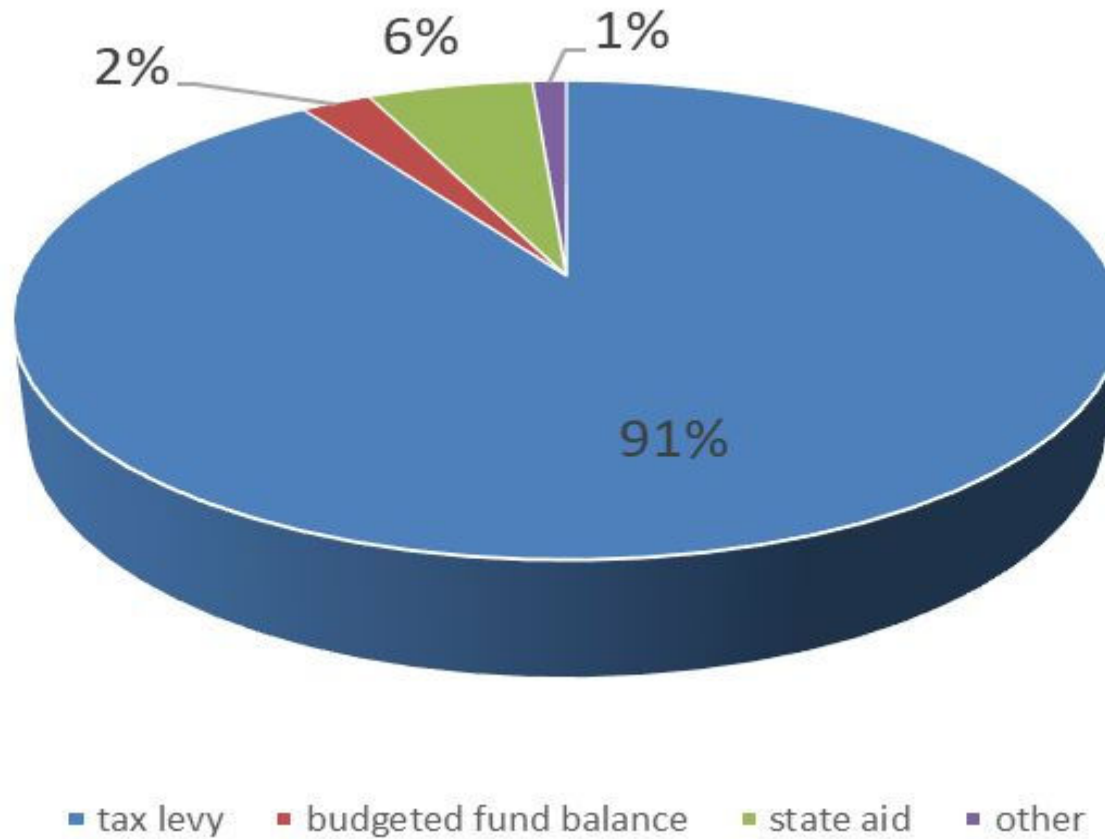
- State aid for 2023 -24 remains at same level as 2022-23. (State aid to be announced March 2)
- Budgeted fund balance from 2021-22 audit: \$2,541,487.
- Local taxes will increase 2% plus amount available from health waiver.
- Capital reserve withdrawal for potential ROD grant projects

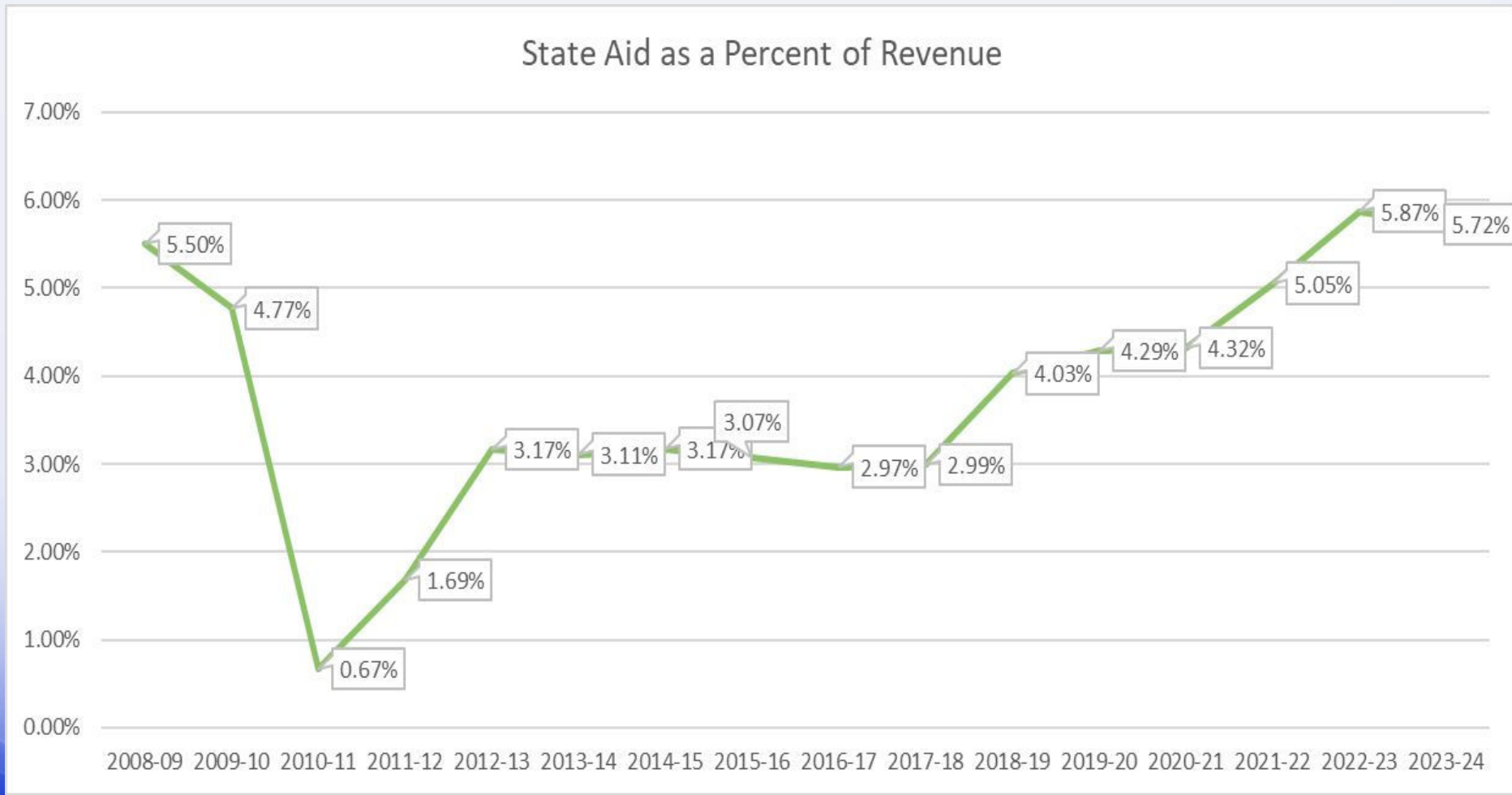

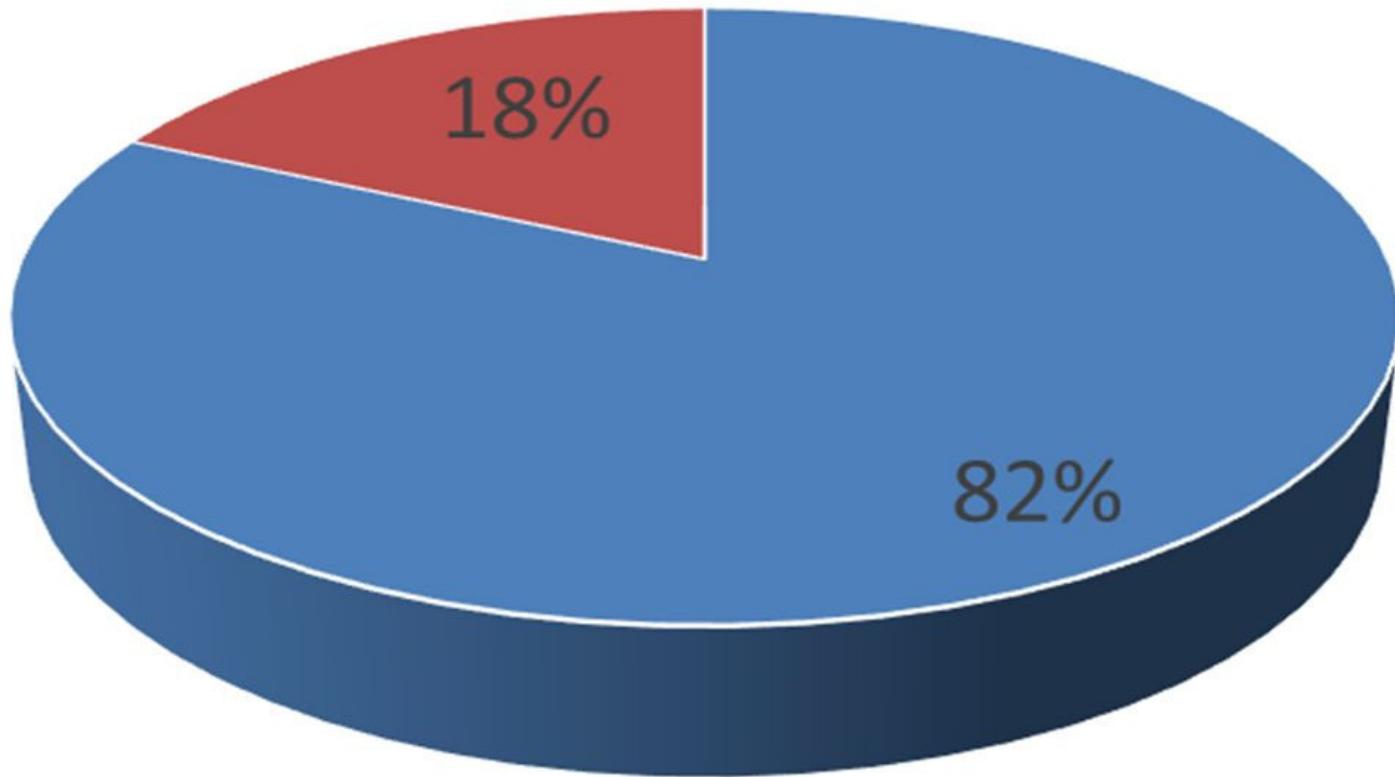

Fixed vs. Non-Personnel/Other Costs 2023 – 24 Budget

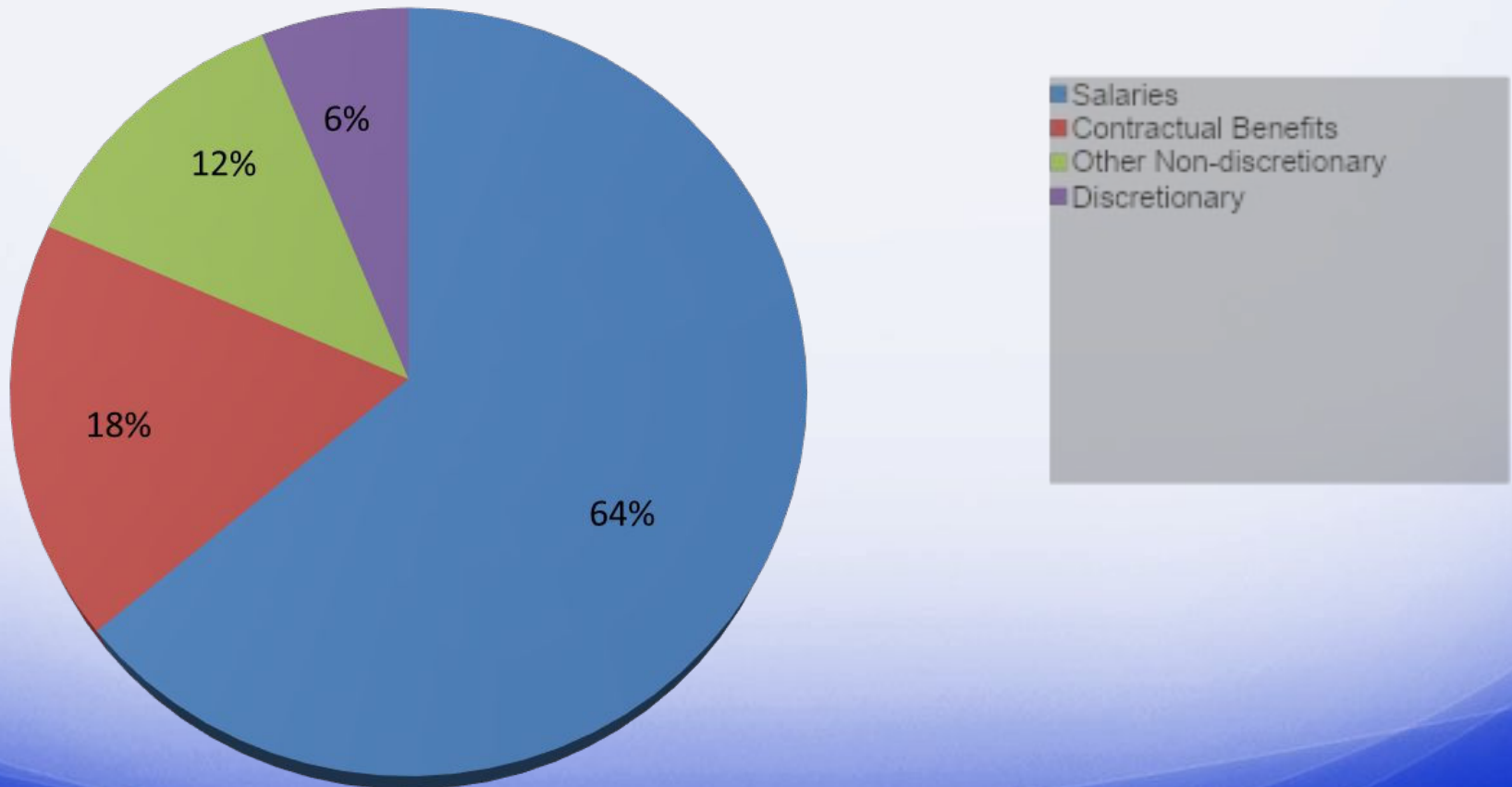

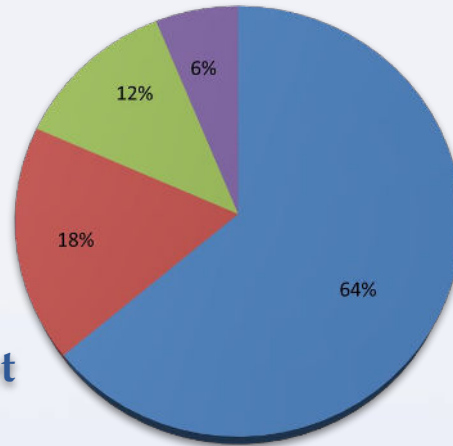
Fixed/Non-Discretionary vs Discretionary Costs

- Deadline to submit the Preliminary Budget: March 20 (approval at March 13th BOE meeting)
- County Review, Discussion & Approval
- Public Hearings: April 24th – May 8th (Scheduled for April 24th BOE meeting)
- Deadline to adopt 2023-24 Budget: May 15th
