Liza:

I write to follow up on public questions from last night's Council meeting. In New Jersey there is no specific list identifying what qualifies as professional services. Instead, "professional services" and "extraordinary unspecifiable services" are excepted from bidding requirements under the Local Public Contracts Law (LPCL) pursuant to N.J.S.A. 40A:11-5(1)(a). Professional services are defined as

services rendered or performed by a person authorized by law to practice a recognized profession, whose practice is regulated by law, and the performance of which services requires knowledge of an advanced type in a field of learning acquired by a prolonged formal course of specialized instruction and study as distinguished from general academic instruction or apprenticeship and training.

[NJSA 40A:11-2(6)]

Extraordinary unspecifiable services are defined by N.J.S.A. 40A:11-2(7) as "services which are specialized and qualitative in nature requiring expertise, extensive training and proven reputation in the field of endeavor."

I remain satisfied that the services to be provided by Winning Strategies Washington – Hoboken Strategy Group, Inc. fall within the definitions of both professional services and extraordinary unspecifiable services.
