- Dennis Dagounis- Spoke about new course Cybersecurity
  - Half Year Course (9-12)
  - This course provides students with a foundation in cybersecurity which involves:
    - Protecting information and information systems from threats to confidentiality, integrity and availability
    - Understanding risks to systems and data
    - Taking action to manage, treat and monitor those risks.
    - Curriculum based on Garden State Cyber
- Dennis Dagounis updated the committee on Rebranding of Courses for the 2024-2025 school year. Reviewing offerings in the Program of Studies which is leading to discussions with department members.
- There is very little Female Enrollment for this year in the classes listed below. Discussion and research into changing the class name to better reflect more 21st Century Skills for both male and female students.
  - Intro to Computer-Aided Drafting and Design 6/29
  - Advanced Computer-Aided Drafting and Design 4/9
  - Advanced Woodworking: 7/38
  - Intro to Technology 6/32
  - Final Metal Working 16/59
  - Robotics 4/31
  - ★ No sequential progression for students to follow.
  - ★ Course descriptions are outdated.
- Beyond the School Day will be running this year.
- K-5 Word Study Update
  - 95 Phonics Core Program training provided to all K-5 teachers and reading specialists on 8/29/23
  - Work continues with building principals, reading specialists and teachers regarding implementation plan
  - Heggerty- has full implementation K-2 for 2023-2024 school year

- The district is applying for the New Jersey Learning Acceleration Program: High Impact Tutoring Grant- Due 9/20
  - Provides funds to eligible districts to prioritize high-impact tutoring interventions for students that have been disproportionately affected by the pandemic
  - Primary focus grade 3 and 4
  - BHPS eligible for up to \$76,000
