Dear Mr. Smith and Mr. Hopkins,

Please provide the following under OPRA and common law right to access:

1. The shared services agreement with Township of Berkeley Heights for Vehicle maintenance that the Berkeley Heights Board of Education, upon the recommendation of the Superintendent and Interim School Business Administrator, approved year two of a three year agreement with the Township of Berkeley Heights for Vehicular Maintenance effective September 1, 2022 through August 31, 2025.
2. The proposal from the Transportation Consultant, LLC to evaluate the Berkeley Heights Township.
3. The contract with Transportation Consultant, LLC along with the scope of work.
4. The proposal from Porzio Compliance Services to perform a security assessment of the district, the cost will be \$10,500.00.
5. The contract with Porzio Compliance Services to perform a security assessment of the district, along with scope of work.
6. The contract with AC Daughtry Security Systems for district-wide central station monitoring of fire, security, and elevator alarms, including inspection, maintenance and repair of alarm systems for the 2023-2024 school year.

Note all the documents being requested are based on resolutions voted on by the board on October 12, 2023.
