Below is a series of screen shots sent to me from an educator in this community, originally sent from Gale Bradford. Included in the screenshots are a personal email from Ms. Bradford in addition to a cover letter for a petition for Angela Penna for President for the BOE, in which Ms. Bradford is personally seeking signers.

There are members in our community, who are named in the cover letter, who serve as leaders of volunteers organizations through appointment or election, who were unaware of the document being circulated, and did not provide consent to being on the document.

- e. Nor take any private action that may compromise the board;
- f. I will refuse to surrender my independent judgement;

Ms. Bradford enlisting the public to support her personal interest undermines the public trust in the Board of Education.

Most troubling is that she asserts that a woman with a full time job cannot fulfill the role of Board President. This wasn't an issue with our prior male Presidents, who both had full time jobs. What message is this sending to the young women and girls in our schools and our community, coming from a member of their Board of Education?

Good afternoon.

I wanted to bring the letter attached to your attention as it has been circulating around town and will ultimately be sent to the county Superintendent as the cover letter to a petition in support of Angela Penna for Board President.

At this time I am not aware who the original author is, but I can tell you Ms. Bradford, Board of Education member, has been circulating this document in a personal email asking for signatures. Both email and letter are attached, below.

I am sharing this with you as it references not only the PTO, but specific Officers within the PTO, and makes a direct connection to the organization and the individuals listed as being in support of only Ms. Penna as President, due to your 'deep and respectful relationship.'

The BH PTO and its Officers are expected to be neutral, especially concerning matters pertaining to and involving individual members on the Board of Education and general board business. Although the letter does not make implications or accusations about other Board Members, the email that was sent with this letter, by Ms. Bradford, alleged Ms. Khanna is not fit for the role, and the reasoning was biased and inaccurate.

There are individuals named in this letter, and associated with their roles within our community, who were unaware and did not consent to being part of this letter, which is quite concerning.

I am not asserting anyone in the BH PTO has been involved in wrongdoing, or even given permission for being named and listed in this letter. In light of this letters connection to the PTO organization, and the organizations commitment to neutrality, I wanted you to be aware of this document being circulated. It would be in the best interest of the PTO organization to disassociate with this letter or any matter involving Board business.

I do find it to be contradictory to BHPTO ByLaws and purpose to have the PTO organization and named Officers being directly connected to this letter, which will be a public document once it is sent to Mr. Palmeiri. This is truly a matter of Board business and no outside organizations, especially those so closely involved in our schools, should be involved or attached to a single campaign.

Letters like this, from elected representatives tied to other elected and appointed representatives within our community organizations, **undermine public trust** and should be avoided at all costs.

The Berkeley Heights Board of Education met on Thursday, January 4, 2024, for the reorganization meeting and to elect a new BOE President and Vice President. The 2024 BOE was divided into a 4-4 split for the position of president. Without a president, the board cannot function or proceed with school district business. The decision may have to be decided by Mr. Daryl Palmieri, Interim Union County Superintendent. The two candidates for president were Angela Penna and Dipti Khanna.

I am looking for your willingness to sign a petition in support of Angela Penna for president of the BOE. The petition with your name and address will be sent to Mr. Daryl Palmieri, Interim Union County Superintendent on Monday, January 15, 2024. I have served with both candidates this past year. 

Mrs. Penna has been a member of the BOE for the past 4 years. During her tenure she served as President of the Board in 2023 and as Vice President in 2022. She has also served on and chaired multiple committees of the Board including the Finance & Facilities Committee, the Curriculum Committee, the Athletics/Co-Curricular Committee, the Technology & Communications Committee, and the Personnel Committee. Before her election to the BOE, Mrs. Penna spent many years as a member of the Berkeley Heights Parent Teacher Organization (PTO) and served as its District President from 2017 until 2019. Prior thereto, she also served as President of the PTO for a number of our town's individual schools from approximately 2010 to 2016. Her

knowledge of and experience with the various issues facing our district and her commitment to the students of this town has been more than proven by her outstanding volunteer track record.

Not only does Mrs. Penna have the requisite experience to continue on as Board President, she has consistently demonstrated the calm, steady temperament and the fortitude necessary to effectively lead Board business and community related affairs, especially in difficult times when tough decisions may be required.
