Thank you for your response. I'd like to clarify the scope of the request. The school-specific budget breakdowns I seek are not deliberative materials but **rather finalized allocations reflecting how the adopted 2025–26 budget is being implemented across each school.** These are not drafts intended to inform budget development—**they are operative documents that allocate public funds following the Board's adoption of the budget.**

The District's reliance on *Education Law Center v. New Jersey Department of Education*, 198 N.J. 274 (2009), is misplaced and, in fact, contradictory to the position taken in your denial.

In that case, the New Jersey Supreme Court held that public access to education funding data including records not directly submitted to the state—is critical for transparency and accountability. The Court emphasized the importance of disclosure when the records in question pertain to how education funds are allocated and implemented. This directly supports public access to finalized school-level budget allocations following adoption of the district-wide budget.

In other words, you can't be serious right now.

To that end, I am revising and narrowing my request:

"Final school-specific budget allocation documents for each school within the Berkeley Heights Public School District for the 2025-26 academic year, reflecting how the adopted district budget is being distributed and executed at the school level."

Please provide these in any available format, including internal spreadsheets, summaries, or documentation shared with school principals or building-level leadership after budget approval.

If any portions remain redacted or withheld, please cite the specific exemption for each redaction and clarify whether the budget for 2025–26 has been implemented as of today's date.

Also thank you so much for the additional material for tomorrows article.

Community Sentiment? What is the evidence of this? Have you ever asked the community what they would prefer to spend dollars on given a choice? The District put out a survey that isolated police and then asked if it was important apart from other priorities. I'm not clear why you had to inject my opinion into this discussion when I am asking for numbers. Yes, I hold the rational position that we shouldn't be spending hundreds of thousands of dollars on programs that not one person can provide any evidence to support their efficacy (that's another question I haven't gotten an answer to).

If I sound annoyed it is because I am, questions about how the District spends any money is met with delay, evasion and red herrings like "I know you are against what the community believes about the police"

Let me then ask this another way, does the number on the ACFR for security include all police spending? If so, how was that number arrived at? The math used to come up with that number should include the spending outside of SLEO and SRO - in other words that work should have already been done and should be easy enough to provide. If it's not part of the security line on the ACFR where was it put? How can the District not have the ability to pull what it is spending on something like police in schools - does it just exist on paper - this isn't tracked on a spreadsheet or database?

It's a simple question that should be easily answered by a Business Office that kept proper track of how its finances are spent.

Also, now that the budget has been submitted, I am requesting via OPRA the School Specific Budgets for each school connected to overall budget submitted to the county. These are not drafts.

We don't have the total of how much the district paid last year and YTD for police services outside the SRO/SLEO contracts readily available. This cost is part of the monthly billing and would be a summer project for someone to complete. This amount is part of what is reflected under security in the ACFR.

I believe you misinterpreted my response as the focus was on **outside the SRO/SLEO contracts**. My understanding is that we are billed monthly for the services and to determine the amount paid outside the contracts, AJ or the office staff would have to go bill by bill to separate out the costs. This is not something that is an immediate priority at this time of the year. Being a summer project does not mean that it would take the whole summer. Again, I know that you don't agree with spending money on security, but we are doing so within budget and according to the Board approved agreements.

This is really concerning — the ACFR for last year is already done, and even if it weren't, it shouldn't take this long to figure out how much is being spent on security. That's a major red flag.

Before I say anything publicly, I want to make sure I'm understanding you correctly: Are you saying the District can't provide a total figure for its security spending? Even for last year? Despite a completed Audit and budgeting process?

If that's the case, either the books are a mess or the response isn't accurate — and either way, that's a serious problem.

I have cc'd the office of the State Comptroller as I am sure they would be interested in hearing if the District cannot supply this number for last year after a completed audit without needing to use the entire summer. It would be a sign that the information the District provided to the state was inaccurate.

I'm planning to publish on Tuesday. If I don't hear back by then, I'll assume your previous response stands and will move forward with publishing and following up with OSC. I've been asking about this for months, starting with the original discrepancy. The District's had more than enough time to give a clear answer.

Policy Approvals

Watching the Board enable what was clearly a political stunt by Ms. Stanley felt like a step backward—straight out of the playbook we thought had been retired. Doing this with the principals present in the room not only violated Board policy but came off as staged and deeply unserious. This wasn't responsible governance; it was performative.

Dr. Feltre: We'll be watching closely how you use the new policy authority to push through state-mandated updates without a full Board vote. Streamlining procedural changes is one thing—but using that process to slip in more substantive revisions would be something the community neither expects nor deserves.

To Mr. Dillon and Ms. Terrero: Why not propose an amendment or push the vote to the next meeting based on your belief that the Board should be involved? And when Ms. Stanley bypassed procedure at the end of the meeting, why remain silent? Do you genuinely believe it's acceptable to introduce and approve policies with no public review or Board discussion, especially at the tail end of a meeting?

To Natasha and Dr. Foregger: You had the power to break quorum and stop the vote. Why didn't you? Note: the people who didn't like you before still don't like you. Not because of your votes, but because of ego. Stop trying to win them over—it's never going to happen. Instead, do what's right for the District. When a Board member violates policy and the Superintendent cheers it on, walking out is not a protest—it's an obligation.

Police Pay Rates

On the Town Council agenda for Tuesday is an ordinance that adjusts police pay rates. While this likely won't affect SRO or SLEO compensation (which are governed by separate contracts), it almost certainly will impact what we pay officers at school sporting events.

Can someone confirm what we currently pay off-duty officers for event coverage? During regular hours the rate will be \$40-Why would we need police officers during regular hours- don't we already have a literal department in our schools?. Have we used even more cops during regular hours? The rates outside of those hours are higher.

Here are the new proposed rates:






