Laura, feel free to call me directly if you want to discuss further. But the actual, truthful explanation is below, and there most certainly is no OPMA violation, nor any activity going on to "hide" any information from residents. And when you're talking about what is legally required and what is not in regards to public notices and OPMA, it IS very important to make the distinction if something is required or not.

- The notice of the meeting was sent to the papers on May 28; the public notice says no action will be taken
- The agenda was posted May 28 in our AGENDA section of our website (screenshot below)
- The person in our office who posted the agenda just didn't add the agenda to the CALENDAR section of our website. I said earlier in this thread to you that it wasn't put on the actual calendar until today (as seen below); it is not required to be on the CALENDAR section but we do it as a courtesy and to make things easier to find for our residents. It is not a legal requirement.

Also, I have the email sent to you from our Deputy Clerk – she merely confirmed that the meeting was in Council Chambers at 6:30 and said she thought it was on the Township website on the Rec page (agenda page).

The bottom line is, human beings sometimes make mistakes. And if a mistake was made by someone here that resulted in the meeting not being added to the website in the *multiple* places we try to post notices for added convenience to our residents, they will try harder next time.
