Ballots cannot be double counted. There will be a "Corrected Ballot" envelope for the voters as well as a "Corrected Ballot" return envelope which notifies the BOE when they count. We also plan to notify any early voters who have not yet received the corrected ballot so they will have a chance to vote for three candidates. Despite proofing and checking more than 70 different ballot types, there is always a possibility of an error.. This is a rare occurrence. We take our work in elections very seriously.
