# Annual Financial Report – Calendar Year 2025

(Unaudited | Cash Basis)

NJ21st is a volunteer-run civic journalism project dedicated to transparency, accountability, and public education on local and state government in New Jersey. Throughout 2025, NJ21st operated without paid staff, stipends, or compensation to editors, contributors, board members, or founders.

NJ21st publishes annual financial summaries not because readers require them, but because transparency builds trust with future readers and donors.

In 2025, NJ21st produced sustained, original civic reporting on a modest budget, supported almost entirely by volunteer labor and out-of-pocket contributions. **This report is intended to show what can be done with limited resources and to demonstrate that NJ21st can responsibly manage and scale public support as it grows.**

NJ21st's reporting reached tens of thousands of readers during calendar year 2025 through its website and opt-in email distribution. Audience engagement was driven primarily by direct readership and email subscriptions, with traffic consistently aligning with investigative and public-interest reporting. These figures are presented separately from this financial summary and are intended solely to provide context to the financial numbers below.

## Contributions

### **Total Contributions Received (2025): \$2,119**

- All contributions were from individual donors.
- No single donation exceeded \$200.
- NJ21st did not accept corporate, political, or bundled donations.
- An organizational filing-fee reimbursement related to IRS compliance was received and applied directly to administrative costs.
